Message from the President and Regional Director



Having the courage to act!

At this time when our lives have been flipped upside down, our Federation has been a model of courage, agility, solidarity, and kindness—now more than ever. We've done this while maintaining active engagement in our major focus: developing and adapting the services we offer producers.

When the pandemic struck, we leapt in with both feet to ensure that emergency public health measures were implemented and followed, both by our staff and by producers. We were highly vigilant and proactive in analyzing the impacts the health crisis would have on the Federation's finances, activities, and projects—and course-corrected accordingly.

Throughout this unusual period, we worked on many projects, especially in one area where we aim to be a key player: growing food autonomy. We will use it to orchestrate and coordinate our actions, both within the Union and in the political sphere, over the next three years. Accordingly, we will ensure the approaches that follow from it meet the expectations of our producers through our expertise high-quality services. For instance, implementing our first agri-environmental strategy to support and encourage our producers in this area speaks to our sincere desire to do things differently.

In order to organize the work before us, we knew recruiting new staff would be a priority. This influx of young blood, together with the expertise of our established staff, is the face of our new present and the bright future we are pointed toward as a Federation.





Administration, Finance, and Human Resources

During the COVID-19 pandemic, our main priority has been managing the crisis while attending to the health and safety of all Federation staff. This meant ensuring that operations continued and securing proper conditions for employees working remotely and in person. To this end, we developed a COVID-19 employee manual and adapted our computer systems to accommodate teleworking.





Annual General Meeting (AGM) 2020

Given the exceptional circumstances this year, the Federation AGM took place remotely over Zoom on October 27, 2020, with 39 people in attendance. Our Report on Activities 2019–2020 was released online the same day, including in video format on YouTube.

Winter AGMs 2021

Firstly, the level of participation and high turnout at the winter AGMs of our 11 local syndicates were encouraging in terms of the diversity in genders, production types, and business models involved. Without a doubt, these meetings created opportunities for friendly encounters and constructive discussions, not to mention the election of 14 directors, a majority of whom are women.

Secondly, the "Bienvenue à nos AGA à l'envers" (Welcome to our backwards AGMs) campaign showcased our members' creativity and fighting spirit. Given how 2020 turned everyone's lives upside down, it seemed only fitting for local syndicate presidents to depart from their usual practice and reverse the agenda of all AGMs (which took place over

videoconference): they began with a friendly discussion period off the top before moving on to the formalities. As a final add-on, our presidents all took the plunge and agreed to appear in light-hearted videos designed to showcase their members' involvement. This initiative formed part of the province-wide "S'impliquer, c'est bâtir l'avenir" (Engagement means building the future) campaign.





Welcoming New Farmers

The Federation created a policy of welcoming new members on a rolling basis. Accordingly, since October 1, 2020, the regional Federation and local syndicates have been responsible for organizing a welcome for all new members within two months of receiving their file. At the end of the process, each new member is invited to attend an activity organized by their local syndicate within six months of joining. The policy, which was developed by the Democratic Life Committee, speaks to a basic principle in unions: fostering a sense of belonging by making new farmers feel included in the organization that supports and represents them. A total of 138 producers went into business in our region between August 1, 2020, and July 31, 2021.

Training for Newly Elected Members

To give newly elected producers a set of resources to carry out their duties, we invited them all to a training session entitled *Coup d'œil sur le syndicalisme agricole* (An overview of farm unionism) last April. The session included an overview of agriculture, the legislation in effect, the history and foundations of the UPA, the activities that make up democratic life, Board members' roles and responsibilities, and finally the mission, operation, and services of the Federation.

UPA Awards

The Marché de l'Outaouais won the UPA's Gérard-Filion Award for Development for its Marché de l'Outaouais cooperative revitalization project. The award was presented at the *Grande fête agricole et forestière* held at the 2020 General Congress. Farmers in the Collines de l'Outaouais, Papineau, and Vallée-de-la-Gatineau local syndicates contributed to the project. Another project developed in our region was a finalist in the Promotion category for *Je me cultive, de l'école à la ferme*, an in-class and on-farm agricultural education program developed by farmers in the UPA Laurentides–Pays-d'en-Haut syndicate.







2020 Drought Operation

The UPA launched *Opération sécheresse* (Operation Drought) to support farm businesses across the province that were affected by rain shortage in 2020. In response, the Federation took charge of efficiently putting forage sellers in contact with buyers to make up for shortfalls. To help with this, the Federation created a regional hay committee, collected and compiled data, and created a dedicated web page on our website. We held virtual meetings to share information on how the AgWeather Quebec website works and on crop insurance for affected farmers.

Agriculture Minister's Tour

In July 2021, André Lamontagne, Minister of Agriculture, Fisheries and Food for Quebec, toured the Hautes-Laurentides sector with Chantale Jeannotte, MNA for Labelle. Federation President Stéphane Alary and UPA La Lièvre President Benoit Legault took the opportunity to speak with them about the agricultural issues facing our region.







Eating local, now more than ever!

In response to pandemic restrictions, which in turn meant replacing the annual *Portes ouvertes sur les fermes du Québec* event with alternatives, the UPA founded the *Mangeons local plus que jamais!* movement. In addition to the widespread media attention the campaign received, the movement also saw the launch of a mobile app designed to help users locate farmers who sell their products on the farm. Farmers' markets, processing businesses, and restaurants were later added to the app. So far, profiles from 115 farms from the Outaouais and Laurentides regions are listed.

To inspire people to eat local food, the UPA decided to pair Quebec public figures from various fields of endeavour with regions that hold a special meaning for them. The designated ambassador for Laurentides was actor and comedian Emmanuel Bilodeau, while Outaouais's selected representative was sommelier Véronique Rivest. The ambassadors toured the region and shared about their experience on social media.

Each of the ambassadors spoke about how important the local food cause was to them and helped fuel the current enthusiasm for citizens to show farmers some love. Artist and long-time friend of the UPA Marie-Eve Janvier joined Kamúy restaurant owner Paul Toussaint in discovering the agricultural attractions in Montreal and Laval.





Communications

The Federation employs a wide range of tools to share information on current issues pertaining to agriculture and farm unionism. Thanks to our relationships with local and national media, we were able to sustain a good media presence in the region. We issued five press releases and published 13 news stories on the news section of our website.

Agriclimate

Created in 2017, the Agriclimate project is a province-wide initiative whose aim is to deepen participants' understanding of climate change in agriculture and to help implement the best solutions for coping with it. In our region, the first phase of Agriclimate concluded in fall 2020 with the development of a regional adaptation plan as well as adaptation profiles for Outaouais and Laurentides. These documents are available at www.agriclimat.ca. In addition, the 2020 Outaouais-Laurentides Agriclimate Forum, which took place in November, was a unique opportunity for participants to help regional farms adapt to climate change. The expected impacts for five different agricultural production types were discussed. The aims of Phase 2, which got under way recently, are to form a network of four pilot farms, to develop a diagnostic process, and to carry out group-level initiatives.

Regional Wetlands and Water Bodies Plans (PRMHHs)

Under the Act respecting the conservation of wetlands and bodies of water (LCMHH), each RCM is required to complete a PRMHH to be submitted to the Minister of the Environment and the Fight Against Climate Change by 2022. Numerous RCMs began or continued developing their PRMHHs in the last year. Meanwhile, the Federation implemented an action plan enabling farmers to make their voices heard through this process, especially when it comes to ensuring that conservation efforts do not disproportionately affect the agricultural zone and preventing bans that punish activities that take place within the zone. As a result, various consultation efforts took place, including online workshops and a survey to gather farmers' ideas, questions, and concerns. About 30 directors attended two training sessions that dealt with how to include agricultural issues in PRMHH development processes. To help facilitate information sharing, representatives were designated in each of the local syndicates involved. Lastly, the Federation created a page about this issue on its website. The Federation's involvement proved especially important in Laval: a brief was submitted to the city requesting that irrigation basins be removed from maps of wetlands.





ALUS Program in the Outaouais Region

The Federation signed an agreement with ALUS Canada, thereby kicking off a three-year agri-environmental project that can be renewed in future. The initiative will bring new leadership to the agricultural sector for agrienvironmental activities in the region. Ours is only the second Federation, after Montérégie, to get involved in the ALUS venture. We formed a consultation committee to determine and prioritize the projects to be funded. Eight farms across three regional county municipalities (RCMs) were selected to participate in the agri-environmental restoration program for 2021. Nearly 7.5 hectares will be equipped with riparian strips or windbreak hedges, for a total of 1 km of planted area and 5 km of riparian buffers. A further 4 hectares will be maintained as pasture reserves to protect at-risk bird species. Several meetings and presentations took place to solicit involvement from regional partners.

ALUS helps farmers and ranchers build nature-based solutions on their land to sustain agriculture and biodiversity for the benefit of communities and future generations. We would like to highlight the support of Environment and Climate Change Canada, WWF-Canada and the Weston Family Foundation for 2020-2023.

Sustainable Agriculture Plan (PAD) 2020–2030

The purpose of the Sustainable Agriculture Plan (PAD), with its budget of \$125 million, is to speed the adoption of responsible and effective agrienvironmental practices by placing farmers at the heart of the action. About \$20 million is earmarked for nation-wide initiatives to be implemented by farmers' organizations. Accordingly, our Federation worked in partnership with its counterparts in Montérégie and Centre-du-Québec to promote soil health and conservation in the region through workshops and incentives for implementing beneficial practices.

Protecting Farmland

In the last year, the Federation examined 103 applications to the Commission de protection du territoire agricole du Québec (CPTAQ) in collaboration with local syndicates. Of these applications, 82 were from individuals; 21 were from municipalities, government departments, and public and private organizations; and 17 were for agricultural zone exclusions.


Meetings were held with the CPTAQ, the city of Mirabel, and the UPA Confederation to end dumping on illegal dumping sites. A legal action has been filed with the Tribunal administratif du Québec (TAQ) to object to a proposed development of 600 homes within the agricultural zone as part of the Fore Golf file in Mirabel (the Le Diamant Golf Club). Regarding the A-19 extension between the A-440 and the A-640, Laval-based farmers received support to lobby the MTQ and the city of Laval to guarantee that farm machinery will be able to safely access farm fields. Discussions were also held with the MTQ to avoid any negative impacts on farming activities taking place adjacent to the right-of-way for the north span of the A-50. An analysis was conducted and briefs were submitted concerning the city of Laval's proposed urban development code; these had to do

with farm product marketing and the expected impacts of the proposed measures on farming activities. This arose from a request for special support from the UPA Laval syndicate.

The Federation also helped with the UPA's provincial land-use planning policy renewal and was involved in the Communauté métropolitaine de Montréal's farm consultation committee.

Land-Use Planning Training

In fall 2020, a training session on land-use planning was offered (in English and French) to local syndicate directors. The aim was to teach participants about the main components of the *Act respecting the preservation of agricultural land and agricultural activities* (LPTAA) and of the Federation's land-use planning policy.





Agricultural Employment Centre

Human Resources Management (HRM) Service Hub

The CEA continued offering services to support farmers in HRM, including recruiting and placing local labour as well as preparing applications for temporary foreign workers (TFWs). It also continued to provide coaching in workplace health and safety. The team welcomed two new employees.

Employer Committee

J'y vais sur-le-champ Campaign

The CEA also invested heavily in supporting employers who sought help from the *J'y vais sur-le-champ* initiative, which began in spring 2020. The initiative enabled them to recruit local labourers and keep seasonal farm workers employed for at least 25 hours a week, making them eligible for a \$100 weekly incentive from the government.

Temporary Foreign Workers

With TFWs having arrived late or not at all from their countries because of the pandemic, many sought the help of the CEA for applications to extend contracts and transfer TFWs from one farm to another.

In partnership with the *Centre d'intégration en emploi Laurentides*, we also formed a task force to answer questions from TFWs on various topics. We visited 24 farms in total and held 17 virtual meetings; we met with 413 workers in all.

Workplace Health and Safety

The CEA addressed various questions surrounding labour standards, prevention in workplace health and safety, various changes, and the new measures handed down from public health pertaining to the different regions and sectors. It also developed a webinar on COVID-19 measures in February 2021.

Agricultural Training and Employment Integration

The CEA also promoted various farm labour assistance programs developed by the AGRIcarrières sector committee. These efforts have borne fruit, with 25 applicants in the region having benefitted from training, employment integration, and francization in the workplace.

Connected with the work of the CEA, and in keeping with the farm training support plan (*Plan de soutien en formation agricole*), the two regional agricultural training collectives in our territory (i.e., Outaouais and Montréal-Laval-Laurentides) work to develop continuous training resources for farm clients and serve as roundtables. Continuous training activities are offered in various formats. However, because of the public health crisis, online training offered greater accessibility and therefore ended up being much more important in the last year. This year saw a total of 483 participants in 41 different training sessions offered—a substantial increase over previous years.

Mental Health

In February 2021, the *Écoute agricole* organization held the fourth edition of its wine and cheese fundraiser. Supporters received take-out boxes to enjoy at home this year. A total of 360 such boxes, each containing a meal for two, sold out in a matter of weeks. The event raised \$72,000 to support the organization's mission and help our road workers in Laurentides and Outaouais—a record. Many dignitaries supported the fundraiser, along with farmers, agricultural stakeholders, and citizens. The Federation, together with our local and specialized syndicates, takes this cause especially to heart and stepped up to sponsor the event.

Across Outaouais and Laurentides, we currently have three road workers on the front lines who listen to and coach producers, their family members, their employees, and agricultural stakeholders in times of psychological stress or other problems affecting their well-being.



Accounting and Tax Service

Joining the Provincial SCF Network

In March 2021, the SCF CPA Outaouais-Laurentides joined the SCF Conseils services cooperative. This unique resource provides more producers than ever a full range of specialized expert services at affordable prices.

Restructuring

We also overhauled the structure of the service to make it more agile; we accomplished this by giving our accounting technicians a place of prominence, since they are often the ones who make the initial contact with clients. The restructuring is meant to help the organization reach its strategic development and business objectives and optimize its processes. To this end, two positions were created in order to help the accountant process clients' financial statements.

Dedicated Phone Line

The SCF also created a phone line to connect farmers directly with an agricultural economist who is ready to answer their questions about the different assistance programs implemented during the pandemic by the various levels of government.
